Discussion of speeding problems in community

Apart from continuing speeding problems, there was no further discussion.

Any necessary discussion of environmental / dog-fouling issues in community

Dog fouling. Members had noted some recent improvement, and welcomed this. **Planting in barrels.** C'llrs Rita Lawler, Chris Lawler and Michelle Lewis had been carrying out re-planting of the barrels, and this was progressing well.

Wild flower seed-sowing. This had been carried out at various locations, including around the cenotaph and on the verge outside the Welfare Hall. It was noted that mowing had been carried out around the cenotaph, which would prevent the seedlings from growing. C'llr John Cole undertook to raise concerns over this in County Hall. Members discussed signage to draw attention to the need to leave these areas uncut. **Bin collections.** C'llr Veronica James raised concerns about food waste being strewn around during bin collections, due to careless practice of operatives collecting the waste. Members to monitor the situation. C'llr John Cole mentioned that the bin lorries may not be fit for purpose, and the Refuse Service in P.C.C. was aware of this issue. **Civic Amenity sites**. It was mentioned that the closure of some sites on certain days of the week had removed the need for the total closure of any sites for the time being, though this was continually under review in P.C.C.
