## **County Councillor's report**

C'llr John Cole had no significant issues of concern to report, but had received a number of positive comments from local residents about the flower beds around the community.

## <u>Discussion of any applications received for co-option of new councillors</u> No applications had been received since the June monthly meeting.

## Discussion of any nominations for community governor to St. Mark's School

C'llr Alison Palmer expressed a willingness to continue in the role, and was nominated to do so (proposer C'llr Michelle Lewis, seconder C'llr Rita Lawler). Clerk to inform school accordingly.

# <u>Discussion of arrangements for siting of public bench to mark VE-80 commemorations</u>

Members were informed that the proposed site at the junction of Site at Greenhill Park Drive and Greenhill Crescent had been rejected by P.C.C. as unsuitable. Other sites considered included close to the Cenotaph, and somewhere within the Welfare Field area.

C'llr John Cole suggested that the bench could possibly be sited in the Welfare Playing Field, on the site of the existing broken bench close to the Pembroke Road entrance to the playing field / playpark. He suggested that the existing bench could be removed, renovated, and subsequently relocated elsewhere in the playing field. Members were favourably disposed to this idea. It was left for C'llr John Cole to consult with the other Welfare Committee members. Agenda item to be tabled for further discussion / decision in October. In the meantime, C'llr Michelle Lewis undertook to look into various options for a suitable bench style. C'llr John Cole undertook to obtain photographs of a possible suitable design of bench based on one currently sited in Tenby, for consideration in the October meeting.

## Any necessary discussion of environmental / dog-fouling issues in community

**Flower beds.** Members commented on how well the flower beds had done this season.

**Wild flower seed-sowing.** This had not been a success, with no seeds having germinated. C'llr John Cole offered to obtain suggestions from someone in the Roch area who had been successful in a similar planting exercise, for possible use in the future.

**Remembrance Day commemoration.** Members commented that it would be good to have some suitable flowers blooming around the Cenotaph in time for the Remembrance Day commemoration.

**Flower barrels.** C'llr Rita Lawler reported that two fuchsias had been taken from the flower barrels around the community.

**Biodiversity Enhancement report.** C'llr Michelle Lewis had made some notes on achievements in this area since the 2022 report had been published. She undertook to update the report accordingly. Agenda item to be tabled for approval in October. **Litter collections.** Members noted a tendency in the community for rubbish receptacles to be left out for too long after the bin collections had taken place, thus causing the neighbourhood to look unkempt.
